Social Media Contests

Official Rules

The following rules apply to all online (Facebook, Twitter, LinkedIn, YouTube, rbt.com) contests unless otherwise noted:

1. These contests are in no way sponsored, endorsed, administered by, or associated with Facebook, Twitter, Linked In, YouTube, or any other social media platform.
2. Participants and winner(s) must be residents of the U.S., its territories, and possessions, who have a valid social security or tax ID number. Winners may be required to show proof of identification.
3. Participants and winner(s) must be 18 years of age or older.
4. Participants and winners must reside within Republic Bank & Trust's service area as defined in the Bank's Community Reinvestment Act (CRA) file.
